This document lists every decision to make to progress in the game, without describing anything else in detail.

The Ranch Turnabout

Lobby:

Choose whichever option you prefer when speaking with Malon,
Receive Malon's Pictograph.

Courtroom:

Receive the Autopsy Report, Saw, Ranch Inventory, and Milk Shipments.

Cross-Examination: "The Reasons for Arrest"

Present the Saw on Statement 4 or 5,
Receive the Bloodied Cloth.

Cross-Examination: "The Scene Behind the Door"

Receive the Perfume,
Present the Autopsy Report on Statement 1 or 5.

Cross-Examination: "What I Actually Saw"

Press Statement 3,
Present the Bloodied Cloth or Saw on Statement 4,
Accept Zelda's new evidence; receive the Oil Bottle.

Cross-Examination: "My Findings"

Press all the statements.

Lobby:

Receive the Milk Shipment Return and Lon Lon Milk.

Courtroom:

Receive the Ranch Inheritance Document.

Cross-Examination: "The Matter of Motive"

Press Statement 5,
Select "Add it to the testimony",
Present the Perfume on the new statement,
Select "Somebody's movements",
Present Ingo's profile,
Select "Find the receipt".

Cross-Examination: "My Non-Suspicious Movements"

Press Statement 4,
Select "It IS important",
Present Ingo's profile on the new statement,
Select "No" when asked whether you accept the explanation,
Present Malon's Pictograph.

Revisualization:

Select "[Person] is the murderer",
Select "Talon's blood got on them",
Select "They were thrown in a fire".

Cross-Examination: "Too Busy for Murder"

Present the Lon Lon Milk on Statement 3.

Rebuttal: "The Murder Weapon"

Statement 1:

Press,
Select "Yes".

Statement 2:

Present the Ranch Inventory.

Statement 3:

Press,
Select "Disposed of it?"

Statement 4:

Present the Ranch Inventory,
Select "Something on the inventory itself",
Point to Ingo's name.

Statement 5:

Present the Milk Shipments,
Select "The contents of the bottles".

Statement 6:

Present the Milk Shipment Return.

Courtroom:

Present the Ranch Inheritance Document,
Point to the bottom-left bottle.

Lobby:

Present the Oil Bottle.

Turnabout Thief

Cross-Examination: "The Great Heist"

Press Statement 3,
Receive the Wares List,
Present the Wares List on Statement 8.

Cross-Examination: "Hoot!"

Press all the statements.

Revisualization:

Select "Neither of them",
Select "Not them either",
Select any option.
